Karl Marx has left many contributions to sociological theory. He is a German philosopher and socialist and is best known for his belief in a communist society. Throughout his lifetime he faced many struggles. In the mid 1800s, he was involved in the upbringings of the monarchs, leading him to be expelled from Germany and France (Pederson, 2024). He then spent the later parts of his life in England where he lived in poverty (Pederson, 2024).

He helped write the Communist Manifesto, which was published in 1848 and this led to the creation of his theory "Marxism". Aside from his theory, he is widely known for his critiques of Capitalism. Capitalism is an economic system, created by Adam Smith (1776), where the means of production and services are controlled by private ownership and its main goal is to gain profit. According to Marx, Capitalism "creates a different world" (Pederson, 2024). Not only does it affect our country, but it impacts other countries which explains why many items we obtain are made in countries other than the United States. The system's main goal is to make the most money possible.

An article from the New York Times (2024) provides a great example of how a capitalist society works. While yes, the team can play in shiny and expensive shoes, they prefer wearing these sandals due to the practicality.

The sandal slowly started becoming part of the fashion industry. There were magazines and articles around the world that had people modeling these sandals. Soon after the sandals became well known, Gucci wanted to create a pair just like them. The original pair of sandals which costs \$1.50 is now being created by a brand and sold for a price of around \$1,000. Due to the private ownership of a capitalist society, brands have the freedom to do this. Because the sandals were created to replicate the ones used in the amateur games of soccer, the performance of the team affected the sales of the sandals. Whenever the team lost games, sales of the sandals decreased.
