- 1. In my state of South Carolina, the racial makeup is 65.9% White American, 27.7% African American, 0.4% Native American, 1.8% Asian American, 0.1% Pacific Islander American, and 2.1% from two or more races. The social class makeup is a median household income of \$51,740, with 17.2% of the population living below the poverty line. The gender makeup is 50.7% female and 49.3%, male. The age makeup is as follows: 5.1% under the age of 5, 18.6% under the age of 18, and 12.8% over the age of 65. The overall disabled population is 30%, with higher rates for those over 65 making up 19.8% of the disabled population. The family makeup in South Carolina is as follows: 31.9% of households are married couples with children, 28.8% of households have children, but no husband present and 15.1% are non-family.

6. The overall crime rate in South Carolina is 3,462 per 100,000 people. This means there are about 33 crimes per 1,000 people in the state. In 2021, the reported number of violent crime incidents was 20 000. The number of property crime incidents was reported to be 50,000. The most common type of crime is property crime, which includes burglary, larceny, and motor vehicle theft. The second most common type of crime is violent crime, which includes murder, rape, robbery, and assault.

The demographic groups that tend to get arrested most in South Carolina are blacks and Hispanics. The most common type of crime for these groups is property crime. The rate of blacks being arrested for property crimes is five times higher than the rate of whites being arrested for property crimes. The rate of Hispanics being arrested for property crimes is 2.5 times higher than the rate of whites being arrested for property crimes.
